Terms and Conditions of Happy Trails Farm Animal Sanctuary Inc. Foster Home Program

• I agree to provide quality feed on a regular schedule, proper housing and exercise for this animal, and will provide plenty of fresh water daily.

• If the animal needs medical attention, Happy Trails Farm Animal Sanctuary, Inc. must first be notified and we will schedule one of our veterinarians to take care of the animal, unless other arrangements are made with the foster home at the time of notification. In the event of an emergency only can the foster home make immediate arrangements for medical help for the animal without contacting Happy Trails first. In the event of an emergency, Happy Trails must be notified immediately after a veterinarian is contacted. Happy Trails will reimburse the foster home for the emergency veterinary expense

• Happy Trails Farm Animal Sanctuary, Inc. retains custody of the animal being housed at the foster home. If at any time the foster home wants to formally adopt this animal, regular adoption procedures must be followed and any adoption fees must be paid. Otherwise, the foster home agrees to care for this animal until it is placed in a permanent home or for the amount of time listed on the contract.

• An informational sheet is provided to the foster home with each animal, providing medical history, behavior assessments and special needs. All information is provided to the best of our knowledge, but often information is provided second hand from auctions and owner

surrenders and we do not guarantee the information as perfectly accurate.

- As a foster home, I agree to talk with potential owners about the animal and agree to allow them to come onto my property with my supervision to visit the animal they are considering adopting. I will provide adoption applications (supplied by Happy Trails) to interested parties. I understand that a Happy Trails adoption counselor must first visit the home and complete the adoption process before my foster animal is allowed to leave my property and become adopted by new owners. I agree to contact Happy Trails about any persons interested in adopting this animal.
- This animal will remain in my possession. I will not sell, trade, give away or dispose of this animal in any way. If I cannot keep the animal for any reason I understand that I must return the animal to Happy Trails, and give them reasonable notice to find another foster home. Foster home shall not give or otherwise transfer ownership of the animal to another party without prior written permission of Happy Trails. If, at some point during criminal proceedings, Happy Trails is granted ownership of the foster animal, the foster home will be given the first opportunity to adopt or place the animal in accordance with Happy Trails standards, rules and procedures.
- I understand that a Happy Trails representative may make home visits to check on the animal. I will cooperate in making the animal and its home available to them upon request.
- I agree that I will not attempt to hold Happy Trails Farm Animal Sanctuary, Inc. responsible for damages which the animal may do to any person or property. I understand that these foster animals are FARM ANIMALS with often unpredictable behaviors, and will exercise every safety precaution when working with them. I will take necessary steps and safety measures to educate others who may come in contact with my foster animal(s) for both their safety as well as the animal's safety.
- I specifically give my permission to an agent of Happy Trails to remove the animal from my premises if the animal is not properly cared for as I have agreed to in this contract, and entry shall not constitute a trespass upon my property.
- Foster home shall not euthanize an animal without Happy Trails's written permission, or unless such action is necessary to prevent the unnecessary suffering of the animal where there is no other reasonable remedy of relief.
- I have read, understand and agree to ALL of the above provisions relating to the foster care of an animal.

The information I have provided above is true to the best of my knowledge, and understand that I will also need to sign the liability release form concerning the foster animal.
