What We've Accomplished Together

Through our supporters, in 2014 to date so far we have:

- ...adopted out over 40 animals, including horses, sheep, goats, mini-horses, a mini donkey, and feathered friends
- ...provided extensive community outreach and educational programs. We have given 14 presentations to schools and special interest groups and reached over 600 students and members; made 4 nursing homes visits and visited with 120 residents; attended 7 community events and reached over 3,000 people.

demand for animal care, animal adoptions and administration

- ...welcomed 2,000 visitors at Happy Trails Open House in June
- ...made many repairs and key purchases thanks to generous donors
- ...cleared new areas of our woods and installed new fencing to expand our horse turn-out paddocks
- ...replaced the engine on our dump truck when it blew up at the beginning of the year
- ...upgraded areas of the sanctuary regarding electrical needs

At the time of this appeal there are approximately 200 animals in our rescue and rehabilitation programs. This number changes constantly depending on the rescues and adoptions on any given day.

Daily Operating Expenses

Often it's our Annual Appeal that helps the most in funding our daily operating expenses.

Because of the eye-opening number of abuse cases competing with each other for our assistance this year, our daily and animal care expenses have far exceeded those of the previous year. To give you an idea of some of our costs from January to August of this year, here are some facts and figures that illustrate the basic needs of the sanctuary:

2014 January-To-August Bedding \$5,984

Straw and sawdust is used as bedding for the rescued animals and is purchased in bulk.

Grain & Hay \$24,423


Grain is purchased in 50lb. bags, and each week we purchase approximately 1,500

to 2,000 lbs. of grain. Though hay is sometimes donated, we purchase the majority of hay that we use, including large round bales for the paddocks as



Vet & Health Care ... \$31,314

Veterinary expenses include examinations, vaccinations, deworming, radiographs, wound care, gelding and castrations, spay and

neuters, dentistry, surgeries, bandaging, medications, antibiotics and anti-inflammatories, pain relief, opthalmalic exams, and lameness testing.



Many of the rescued horses have sadly neglected hooves and often require special care as they begin to learn to walk properly.

Farrier \$1,785

Blacksmiths are used to trim horses' hooves and to shoe or create corrective shoes as needed.

Electricity \$3,370

During the hottest summer months, the recovering animals are provided with access to fans and during colder months they are provided with access to a heat source such as a heat lamp when and where possible. Each shelter also has its own electricity, lighting and power outlets. Power tools and batteries are also often plugged in.

Propane/Fuel Oil \$1,775


Propane is used to heat the rest room and fuel oil is used to heat the house at the sanctuary where our Animal Care Coordinator lives.

Dumpster \$1,105

The dumpster is normally emptied once a week.

Facility Repairs & Maintenance\$17,718

Facility repairs are a constant need, with fences being kicked or broken, stall gates being bent, older roofs leaking, shelters needing painted, doors not opening properly, etc.

Vehicles \$3,053


This cost for upkeep and repair includes two pick-up trucks, the dump truck, the golf cart, the Cub Cadet, farm machinery such as the skidsteer, and 2 trailers.

Fuel (Gas/Diesel) \$4,648

Happy Trails geographical area of assistance knows almost no boundaries. We are constantly transporting animals or driving to assist law enforcement with rescues. We go through a great deal of fuel throughout the year. Diesel is used to run the farm machinery.

Wages \$90,780

Happy Trails currently operates our entire organization with only 4

full-time paid staff members and 6 part-time paid staff members. This small but mighty and dedicated staff makes amazing things happen!

The above items alone total \$174,464 year to date.

Happy Trails 990 for 2013 shows that 98% of all donations go directly toward the rescued animals.

Special Projects and Needs to Sponsor

Facilities improvement projects are many. This grocery list of projects in need of sponsors outlines some of our more important projects and special needs, any of which can be sponsored in part or entirely with naming rights. If a project or special need speaks to you, we invite you to contact us for more information or to visit the site of a project to fully understand its importance and its role in the efficiency and effectiveness of the sanctuary.

New Multi-Purpose Building & Mini-Vet Clinic

The recently constructed 24'x40' 2-story multi-purpose building located toward the front of the sanctuary is designed to house a



small group of pot belly pigs, serve as a mini-vet clinic, and provide storage area for animal-related supplies. Though the building has already been constructed, we are just now reaching out to request sponsors and donations toward its cost. The expense breakdown is:

- Building construction . \$27,000
- Gravel base pad and cement foundation \$3,600
- Electricity \$4,000

This electrical cost will also cover the specialized lighting needed for the area of the vet-clinic to aid

with examinations and treatment of the animals.

- Pot belly pig area (stalls, gates, mats)\$950
 - Mini-vet clinic \$15,475

Constructing the inner walls of multi-purpose building to create the mini-vet clinic. This includes all construction materials, insulation, installing special padding on the lower portion of the walls, non-slip floor mats, and two medicine cabinets.



Horse Barn Roof

This project is an absolute need scheduled for this fall. We need to install a new metal roof over the current rolled roofing on the horse barn that is constantly in need of repairs. We have patched and replaced and repaired the current rolled roofing until it is now beyond anything we can or should repair. The metal roofing and related supplies will cost \$4,300. The labor to install the metal sheeting will be handled by an all-volunteer crew lead by a professional volunteer carpenter.

Concrete Manure Pad

A 12'x12' concrete pad is needed in the area where manure is dumped while waiting to be transported away. This will eliminate the slow but steady unwanted removal of the dirt below the pile each time the pile



is scraped up with the skidsteer. The cost for this concrete pad is \$400.

New Farm Pig Barn

One more new barn is being added out of sheer necessity so we can better care for the farm pigs throughout the recordbreaking cold temperatures that are predicted for winter. This new barn will replace three other smaller and not-so-nice shelters and will enable three groups of farm pigs to live comfortably in one barn, with the body heat from each pig helping to keep them



warmer. This new pig barn will also enable our animal care giver staff to feed and water the animals more efficiently and will help keep their environment cleaner and more sanitary. A second story on this building will allow for hay and straw storage for all animal shelters located in this area of the sanctuary. There are several steps in the creation of this building:

- Construction \$27,000 - Rock/gravel base \$1,750
- Kock/gravei base \$1,750 - Cement pad \$4,400
- Electricity \$2,500
- Stalls (lumber /gates).\$1,300

Special Projects and Needs to Sponsor

Gravel for Driveway

As we attempt to deal with the ever-present mud at the sanctuary, the extension of a usable driveway that reaches further



back to the newer buildings is crucial to have easy and safe access to all areas where animals

are present. Larger gravel is normally put down first on the driveways, with a smaller gravel that packs and knits together placed on top of that. Commercial grade geo-cloth will keep the rock from sinking. The commercial grade geo-cloth is \$500 per roll, and we need 3 rolls. We are estimating that we need 5 loads (20 tons per load) of each type of gravel to get us through the winter season at a cost of \$13 per ton delivered. The total cost of this project will be \$4,100.

Pay-off for the Mortgage on the Property

Happy Trails has nearly paid off the mortgage on the sanctuary. We only have \$29,000 remaining to pay off the commercial loan. We will indeed honor requests to have your donation of any amount go toward paying off the remaining mortgage on the property. It is very exciting for us that this reasonably smaller amount is all that we owe from the original purchase price of \$128.000!

Covered Arena Phase II -Drainage

the building itself and the installation of the first two layers of sand. It truly is a thing of beauty. We have now moved on to Phase II, which includes installing proper lighting and electricity (this portion of the project has already been sponsored) and creating appropriate drainage on all sides of the building (this portion has not yet been sponsored). Between the new arena and the horse barn, we need to lay drainage pipe, cover it with gravel, and create a walkway between the two buildings for horses who cannot get bandages or casts wet. We also need to dig several trenches and install drainage pipe on the South side of the building as well. The total cost of addressing the drainage portion of Phase II is estimated at \$1,800.

Animal Care Giver Staff Sponsor Shifts of Animal Care

It takes an average of six to seven hours for one staff member to complete one animal care shift, and there are two care shifts per day. This means actual hands-on care — feeding grain and hay, scrubbing water buckets and providing fresh water, distributing and applying medications, turning horses out to exercise in paddocks or bringing horses in to the barn, cleaning horse stalls, observing all animals for signs of lameness, illness or injury, deworming, delicing, handwalking horses on stall rest, and providing dry comforters or sleeping bags to the elderly pot belly pigs. \$84 will sponsor one staff member per care shift; \$168 will sponsor two animal care shifts, and \$1,176 will sponsor our animal care giver staff for an entire week.



Planned Giving • Wills • Trusts

Leaving a legacy of compassion for animals and continuing to do amazing work together with Happy Trails through planned giving is a true testimonial to your convictions and an incredible way to memorialize your dreams of spreading peace and healing on this earth in a big way. By including Happy Trails in your estate

planning, you can be the reason we are able to implement new programs, reach more people, rescue more animals, change mindsets, heal the broken and continue to make a big impact in many, many lives.

Planned giving is a way to include Happy Trails Farm Animal Sanctuary in your estate and financial plan. Depending on your giving strategy, there could be immediate or future tax benefits for you. Here are the nuts and bolts of giving options.

PLANNED GIVING OPTIONS:

Gift of cash

Gifts of cash provide an income tax deduction for the year in which the gift was given.

Wills and bequests

Bequests can be made in a new will, or an existing will can be easily amended to include a bequest to Happy Trails. An unrestricted bequest is one that allows Happy Trails to direct your gift where it will have the greatest impact. A restricted bequest allows you to designate what you would like the gift to be used for.

Gifts of Stock

Gifts of stock can be made in two ways. You can call your financial advisor and transfer shares of stock directly from your account to Happy Trails, or you can give stock certificates. You will receive a tax deduction for the full amount of the current value of the gift on the day on which the gift was given, and if the stock has appreciated significantly, you will avoid paying the capital gains taxes due if you were to sell the stock.

Charitable Remainder Trust

A Charitable Remainder Trust (CRT) enables you to give a highly appreciated asset, such as stock or vacation home, to a trust for which Happy Trails is the beneficiary (or one of several beneficiaries). In the trust document, you designate what income you want to receive from the trust. The CRT sells the gifted assets and reinvests the proceeds to provide you with income as

stated in the trust document. You do not pay the capital gains tax on the sale of the appreciated asset, and you receive an immediate tax deduction for your gift to the trust. As a beneficiary of the CRT, Happy Trails receives the gift, or a portion of the gift, upon the death of those indicated in the trust document.

Charitable Lead Trust

A Charitable Lead Trust (CLT) also allows you to gift a highly appreciated asset, such as a stock or a vacation home, to a trust for which Happy Trails is the beneficiary, or one of the beneficiaries. With a CLT, however, the beneficiary first receives distributions for a number of years as stated in the trust agreement. At the end of the stated time period, the remainder of the trust is distributed to whoever is designated in the trust document. Because the ultimate recipients of the trust proceeds must wait a number of years before receiving the gift, the amount of the gift is calculated in a manner that could be extremely favorable to the donor. This strategy may be very effective in minimizing or eliminating the gift taxes that would be associated with an outright gift.

Life Insurance

If you would like to give an insurance policy directly to Happy Trails, and would like it to qualify as a gift with the IRS, you will need to make Happy Trails the owner and the beneficiary of the policy. If the policy is paid up, your charitable tax deduction is usually the cost basis or the replacement value of the policy, whichever is less. If the policy is not paid up, the premiums that you continue to pay on the policy would also qualify for charitable deductions. This is an extremely effective way to leverage your gift to Happy Trails. Depending on your individual situation, incorporating an Irrevocable Life Insurance Trust (ILIT) into your plan may also be beneficial.

He recommends taking leisurely walks barefoot in soft clover.

Every life has value. Even if an animal has not had the good fortune of being adopted, they are cared for and loved at Happy Trails for as long as they are with us. When it's time to assess the quality of life of any animal and pain can no longer be controlled, a veterinarian helps us make that often-tough decision to help them cross the Rainbow Bridge. Until that time comes, we cherish the senior rescued animals, continue to learn from them, and make them comfortable, warm and happy. Just because an animal is old, doesn't mean that he or she doesn't have a lot to offer. We encourage respect for all senior animals.

Top Reasons...

...why the work of Happy Trails is so critically important.

- 1. We make communities safer by addressing animal abuse. Many of our animal abuse cases are connected to other violent crimes. We believe that animal abusers should be held accountable for the suffering they inflict to help prevent the cycle of violence from continuing. Violent criminals initially start out with abusing animals.
- 2. Most humane societies and law enforcement agencies are not prepared to handle abused animals other than dogs and cats. There is a wide range of animal abuse out there that involves many types of animals. When your local humane agency discov-

ers a starved horse, an abandoned goat, or the pig that fell off the meat truck onto the highway, they often rely on Happy Trails to provide transportation, rescue

and rehabilitation services.

- 3. We believe education equals prevention of and creates a new awareness of animal abuse. Bringing any tough topic to light is the first step in addressing it. Animal abuse is no longer an affliction that is swept under the rug thanks to the involvement of Happy Trails. If we're involved, you hear about it. We let you know what's going on and give you the opportunity to make a difference and participate in animal rescue through donating, adopting, fostering, and volunteering.
- 4. We give back to our community in many ways. The rescued animals visit nursing homes through our Farm Animal Visitation Program. We do hospice visits and provide educational programs for students. And the Happy Trails Amish Horse Retirement Program is one-of-akind and accepts retiring buggy and plow horses when they can no longer serve their owners. We rehabilitate these horses and find them adoptive homes.

Our Mission

Happy Trails Farm Animal Sanctuary Inc. is a non-profit 501(c)(3) organization that rescues, rehabilitates, and provides an adoption program for abused, abandoned, and neglected farm animals such as horses, ponies, potbelly pigs, farm pigs, chickens, ducks, turkeys, sheep, goats, and cows. Happy Trails serves the entire state of Ohio and any other state requesting our help, and works in cooperation with county humane societies, animal protective leagues, and local and state law enforcement officers. Animals in our program must have been removed from a situation of abuse, neglect or abandonment by law officials, and cruelty charges must be filed against the person(s) responsible for the crime.
